This is a copy of our Health guarantee covering your puppy. It must be agreed by both parties and is being sold with the following Registration

Limit Registration: Limited registration means you do not have the right to breed the dog. Breeding the dog will result in a breech of contract and any guarantee will be void at that time.

Full Registration: Full registration means you have the right to breed and show your dog.

The I.O.E.B.A. registration will be excuted at the time of purchase. The buyer understands that the puppy will be eligible for permanent registration with I.O.E.B.A and has been fully informed of how to go about the process.

## **DEPOSITS AND PAYMENTS**

- 1. All puppies require a 300.00 deposit. Deposit must be in cash, cashiers check or paypal.
- 2. DEPOSITS ARE NON REFUNDABLE. If something happens to your pup, if one is not available from this litter, your deposit will be transferred to the next/another litter. If you change your mind and do not /can not get the puppy, you forfeit your deposit.
- 3. All shipping cost are the buyers responsibility

## The animal is guaranteed as Follows

1. To be in good condition for the first 48 hours after the delivery to buyer. The buyer agrees to have puppy examined by a Veterinarian within the 48 hours after delivery time for a complete examination. Please keep pup off floor at vets office due to diseases.

If the Veterinarian finds the puppy to have serious physical condition other than bacterial infection such as Coccida or Giardia which is easily treated. The seller will replace the puppy with another puppy of comparable or better quality when available from the same litter or upcoming litter. After the puppy is returned to seller: The seller reserves the right to a second opinion at the expense of the seller. If puppy is not examined within the 48 hrs after delivery the above GUARANTEE is no longer effective.

2. Each pup comes with a Limited Genetic Health Guarantee against death or serious impairment of vital functions until pup is one year of age. If such inheritable diseases is documented by a vet and presented to the seller with sufficient supporting evidence, the buyer will be entitled to a replacement puppy. This guarantee does not cover what in the Bulldog Breed some consider normal or beyond our control: Cherry Eyes, Entropin, Ectropian, Hip

Dysplasia. We cannot guarantee that the dog will not contract Mange. Mange is a multifactorial genetic disease that can be transmitted in a recessive manner. There is much dispute between experts as to the differing specific causes of mange: including environment, stress and nutrition therefore we cannot guarantee against it.

We are not GENETICISTS and cannot predict genetic problems. We DO NOT breed dogs with undesirable conditions, but we cannot guarantee the previous generations did not have above mentioned conditions in their lines, therefore, we cannot guarantee these conditions.

- 3. Puppy will recieve 1-3 vaccines, depending on age and to wormed accordingly. Please keep the puppy away from any unhealthy pets or areas that have been infected.
- 4. The buyer agrees 1. To use kennel name SUNDOWN KENNEL, in the registered name of the dog. To maintain up to date vaccines and wormings. To keep dog in humane conditions. Failure to comply with contract requirements said puppy will result in the repossession of said puppy\_\_\_\_\_\_Initial
